Wellsville Secondary School will again be participating in the Rochester Institute of Technology's High School Junior Awards Program. The Computing Medal and Scholarship Program and the Award for Creativity and Innovation not only recognize outstanding high school juniors, but also highlight RIT's leadership in computing education as well as its creative and innovative programs in many other disciplines ranging from engineering, sciences, business to design, photography, film and crafts.

Brandon Bailey and **Isabel Mariotti**, Class of 2018, have been nominated for the Rochester Institute of Technology Comput-

ing Medal and Scholarship by Wellsville Secondary School Counselors and Administration. They have also nominated **Brogan Bailey** and **Sadie Embser** to receive the RIT Creativity and Innovation Award. Nominees for the awards program must rank in the top 10% of the junior class, demonstrate leadership in school and community, and be pursuing a rigorous college-preparatory curriculum. Students selected to receive these awards are eligible for a \$28,000 scholarship (\$7,000 per year) if accepted and enroll at RIT. Students may use these scholarships to pursue any of the baccalaureate degree programs available at RIT.

The Wellsville Central School District's mission statement continues to guide our budget decisions, "To prepare our students to be successful, contributing members of their communities through excellence in education."

After three years of no tax increase, we've gone a step further this year in preparing a fiscally responsible budget. The 2017-2018 budget includes a .5 (or 1/2 percent) DECREASE in the tax levy. The 2017-2018 budget-to-budget increase is 0.65%. This increase is being covered by an increase in state aid.

We continue to be proud of our staff members who are dedicated to educating our children and greatly appreciate our incredible facilities. We must continue to work together in order to prepare our students to be able to meet the educational challenges they face not only today, but also in their futures.

We are truly grateful to a community that is supportive of our schools and students. We encourage you to be informed about the budget. Join us for our public budget hearing on May 2 at 6 p.m. in our Middle School Room 212A, and then please exercise your right to vote on the budget in the Wellsville Secondary School Lobby (river side entrance) on May 16, 2017, between the hours of 7 a.m. and 9 p.m. We also encourage you to contact the district office (596-2170) with any questions you may have regarding the Wellsville Central School District.





NOTICE IS ALSO GIVEN that a copy of the statement of the amount of money which will be required for the ensuing year for school purpose, exclusive of public moneys, may be obtained by any taxpayer in the District during the fourteen (14) days preceding May 16, 2017, except Saturday, Sunday, or a holiday, at the following school house in which school is maintained during the hours designated: Wellsville Central School District Office, 126 West State Street, Wellsville, NY 14895 between the hours of 9:00 a.m. and 4:00 p.m.

NOTICE IS ALSO GIVEN that petitions nominating candidates for the office of member of the Board of Education must be filed with the Clerk of the District, 126 West State St., Wellsville, NY not later than 5:00 p.m. on April 17, 2017. The following vacancies are occurring:

Three (3) year term to expire June 30, 2020 (2 Vacancies)

PROPOSITION NO. 2 RESOLVED


Medal and Scholarship Program Winner


