
Big 30 Academic Team Nominee

RPI Medal & Scholarship Winner

For more than 95 years, Rensselaer Polytechnic Institute, in conjunction with high schools around the country, has awarded the Rensselaer Medal to high school juniors who have distinguished themselves in mathematics and science. The RPI Medal in Science and Math has been awarded to **Scott Miles** (*at left*), a member of the Class of 2015.

The Medal was first presented in 1916 with two purposes: to recognize the superlative academic achievement of young men and women, and to motivate students toward careers in science, engineering, and technology.

This \$15,000 per year merit scholarship is guaranteed for four years for each medalist who applies, is accepted, and chooses to enroll at Rensselaer Polytechnic Institute. RPI will be hosting an open house for all medalists in the fall of 2014.

From the Wellsville BOE and Administration

Dear Residents.

The Wellsville Central School District's mission statement continues to guide our budget decisions, "To prepare our students to be successful, contributing members of their communities through excellence in education."

Most importantly in this year's budget is the fact that we are proposing a **0%** (**ZERO PERCENT**) **TAX LEVY INCREASE**. Our budget to budget increase is 1.75%. The increase is being covered by a partial restoration of GEA funds.

The Gap Elimination Adjustment (GEA) was enacted in the 2010-2011 school year and has never been fully restored. Over the course of the last four years, the district has lost a total of \$4.4 million dollars to the GEA.

Although we did receive a portion of our state aid back in this year's state budget, we will continue to receive less aid in 2014-2015 than we did in the 2009-2010 school year (-6.60%).

While many school districts across New York State are having to slash programs and staffing, or increase their tax levy well beyond their tax cap, we have been able to maintain our current student offerings and staffing numbers while reducing our tax levy increase for the fourth year in a row.

We believe we have developed a reasonable and responsible budget that provides for the needs of our students, yet recognizes the concerns of the residents of our school district. We will continue to provide a quality education for our children, who continue to be our most important focus.

We continue to be proud of our staff members who are dedicated to educating our children and greatly appreciate our incredible facilities. We must continue to work together in order to prepare our students to be able to meet the educational challenges they face not only today, but in their futures.

We are truly grateful to a community that is supportive of our schools and students. We encourage you to be informed about the budget. Join us for the public budget hearing on May 6th at 6 p.m. in the Middle School room 212A, and then please exercise your right to vote on the budget at the Wellsville High School Lobby (Riverside Entrance) on May 20, 2014, between the hours of 7 a.m. and 9 p.m. We also encourage you to contact the District office (596-2170) with any questions or comments you may have regarding the Wellsville Central School District.





The Board of Education of the Wellsville Central School District, Wellsville, New York, hereby gives notice that an Annual District Meeting on the proposed 2014-15 budget (being Proposition No. 1) and related propositions will be held at Wellsville Central School, Wellsville, New York, Middle School Room 212A, 126 West State St., on the 6th day of May, 2014, beginning at 6:00 p.m.

NOTICE IS ALSO GIVEN that a copy of the statement of the amount of money which will be required for the ensuing year for school purpose, exclusive of public moneys, may be obtained by any taxpayer in the District during the fourteen (14) days preceding May 20, 2014, except Saturday, Sunday, or a holiday, at the following school house in which school is maintained during the hours designated:

Wellsville Central School District Office, 126 West State Street, Wellsville, NY 14895 between the hours of 9:00 a.m. and 4:00 p.m.

NOTICE IS ALSO GIVEN that petitions nominating candidates for the office of member of the Board of Education must be filed with the Clerk of the District, 126 West State St., Wellsville, NY not later than 5:00 p.m. on April 21, 2014. The following vacancies are to be filled on the Board of Education:

- 1. Three (3) year term to expire June 30, 2017, current incumbent, Mr. Alan Mosher;
 - 2. Three (3) year term to expire June 30,

2017, current incumbent, Mr. Rex Olson;

3. Three (3) year term to expire June 30, 2017, current incumbent, Mr. Jody Torrey

Each petition must be directed to the Clerk of the District, must be signed by at least twentyfive (25) qualified voters of the District, must be filed with the district at least thirty (30) days prior to the budget vote on May 20, 2014, and must state the name and residence of the candidate.

NOTICE IS ALSO GIVEN that voting will be held on May 20, 2014, between the hours of 7:00 a.m. and 9:00 p.m. in the High School Lobby (Riverside Entrance) for the voting upon the election of three (3) board members of the Board of Education and to vote upon the acceptance of the proposed budget (being **PROPOSITION NO. 1**) for the school year 2014-15 and:

PROPOSITION NO. 2 RESOLVED that the Board of Education of the Wellsville Central School District No. 1 of the County of Allegany, is hereby authorized and directed to purchase one (1) 77 passenger conventional bus and one (1) 30 passenger handicapped accessible (3 wheelchairs) bus at a total maximum cost of \$200,000 or so much thereof as may be necessary to be raised by taxes on the taxable property of the said school district and to issue obligations of the school district, therefore, in accordance with the education law and local finance law:

PROPOSITION NO. 3 RESOLVED that the Board of Education of the Wellsville Central School District No. 1 of the County of Allegany, is hereby authorized and directed to increase the annual tax levy to an additional \$4,052 and to

pay over such funds to the trustees of the David A. Howe Public Library.

PROPOSITION NO. 4 RESOLVED that the Board of Education of the Wellsville Central School District is hereby authorized to establish a Capital Reserve Fund pursuant to Section 3651 of the Education Law (to be known as the "2014 Building Capital Reserve Fund"), with the purpose of such fund being to finance construction, reconstruction, improvement and equipping of school buildings and facilities; such capital costs being of a type that would be eligible for financing under the local finance law, and costs incidental thereto, the ultimate amount of such fund to be \$750,000 plus earnings thereon, the probable term of such fund to be 10 years, but such fund shall continue in existence until liquidated in accordance with the Education Law or until the funds are exhausted, and the sources from which the funds shall be obtained for such Reserve are (i) an initial deposit of \$250,000, and (ii) amounts from budgetary appropriations from time to time, and (iii) unappropriated fund balance made available by the Board of Education from time to time, and (iv) New York State Aid received and made available by the Board of Education from time to time, all as permitted by law.

AND NOTICE IS ALSO GIVEN that applications for absentee ballots to vote on these propositions may be applied for at the office of the School District Clerk, 126 West State St., Wellsville, NY at least seven days before the date of the aforesaid district meeting if the ballot is to be mailed to the voter, or the day before such district meeting if the ballot is to be delivered personally to the voter. Q & A Related to Prop #4 - Public Vote to Establish Capital Reserve

On Tuesday, May 20, 2014, the residents of the Wellsville Central School District will be asked to vote on a resolution that would allow the creation of a Capital Reserve Fund. This is an important vote for the District and the following Q and A has been prepared to inform our voters.

Q. What is a Capital Reserve?

A. A Capital Reserve is a special bank account that is created by the residents of the District for a special purpose; in this case, construction and renovation of the school buildings and property. It requires voter authorization to be created and to have any funds spent from the account.

Q. Didn't the District just complete two large Capital Projects?

- A. We did. There was a Capital Project in 2003 and more recently, in 2008. These projects addressed many construction and renovation needs and provided for impressive upgrades to all of the District facilities. Construction and renovation needs are continuous and are accomplished through two means:
- 1. Maintenance continual efforts at replacement and repair of the equipment and facilities. These are provided by the yearly

budget and are funded by the taxpayer through our normal budget process. These include preventative maintenance and repair.

2. Capital construction and renovation (such as the previous building projects). These are funded by state building aid and by a local tax payer portion.

When maintenance and renovation occur through a Capital Project, they receive a vastly greater amount of state aid support (approximately 95%) rather than attempting the work by our normal maintenance budgeting process.

We are proposing the creation of the Capital Reserve to secure the local taxpayer portion of work in advance in a Capital Reserve Account (savings account) to maximize the savings to the District and secure funds for these ongoing maintenance and renovation needs.

Taxpayer approval is still needed for any future construction and renovation project and any expense of funds from the Capital Reserve.

Q. Why create a Capital Reserve at this time?

A. Funds for school building projects come from two sources: state building aid and local district funds. The state building aid for any approved project can be significant for Wellsville (approximately 95% of the cost

can be paid by state building aid), but there is always some local cost portion for our tax payers. In the past, this local portion has been paid for by raising local taxes. With the Tax Cap in place, it becomes almost impossible to guarantee that these additional taxes will be available to pay for future construction or renovation. To finance such future construction or renovation, it is necessary for the District to have the local share of costs saved up and secured. This secured savings account is called a Capital Reserve.

Q. Where does the money come from to put in the Capital Reserve?

A. If the amount of money received by taxes and state aid exceeds the amount of District expenses in any year, the remaining amount is called fund balance. Fund balance can be used to fund the amount of a Capital Reserve at the end of the year. The District is proposing utilizing \$250,000 of our current fund balance at the end of the 2013-2014 school year and securing it in a savings account called the Capital Reserve. Thus, the creation of a Capital Reserve would provide us with a means in which to "bank" the local share of a future Capital Project.

Recognizing the need for ethical leadership, Wells College presents the 21st Century Leadership Award to high school juniors who demonstrate leadership ability in high school and community activities and exhibit academic excellence. Idea journals are a physical place to keep ideas safe and a place students can look back at for future writing inspiration. Kindergarten students in Mrs. Giopulos' class have been working on becoming writers during Writers' Workshop almost every day since the beginning of kindergarten. So far, the students have been labeling, adding details, making books of all kinds (list books, pattern books, how-to books), and learning about what authors and illustrators do (write and illustrate). Students also have been enjoying author, illustrator, and poet studies each month during read-a-loud. It is an exciting time when students connect and model their writing/illustrations after a favorite author/illustrator.

On a recent sunny day, students took their idea journals outside to gather ideas based on using some of their five senses (seeing, hearing, smelling, and touching - NO tasting) and write about later during Writers' Workshop. The connection between reading and writing helps to strengthen overall student success and confidence. The idea journal is meant to connect student ideas and their future writing, but it also serves to show their writing growth over time.

Mystery Readers

Schools across the country celebrated reading during the month of March. As part of that celebration, Mrs. Murphy's second grade class welcomed nine parents into their classroom as Mystery Readers. Each of the Mystery Readers sent in five clues about themselves (before they actually came to read) and the children tried to guess their identities. The parents then gave time out of their day to come and read to the children and share the importance of reading.


