A Message from the President of the Board of Education & the Superintendent

Dear Residents,

We want to announce a 0% tax levy increase for 2022-23. We are proposing a budget of \$33,474,916.

The Board of Education and Administration want to express our sincere gratitude and appreciation for your support of our students and staff throughout the pandemic.

As responsible stewards of our taxpayers' investment, we are proposing the construction of a new athletic pavilion (Proposition 4). This project reconstructs the current concession and bathroom facility created in the late 90s at the turf field. It has reached the end of its useful life. We propose a state-of-the-art athletic pavilion offering ADA compliant restrooms at the turf level and the Baseball field level, a locker facility, athletic storage, concessions, and public announcement facilities on the current site as Proposition 4 on our budget ballot. This is funded through our voter-approved capital reserve savings and the use of fund balance. This provides a means of financing this work without increasing taxes.

We also propose a new sustainable means to keep our facilities current. As part of our yearly budget, we include a new cycle of annual construction improvements each year. This construction work would be funded through annual state aid payments provided each subsequent year following the construction. Our first years' work would be to refurbish the Elementary gymnasium, including new bleachers, wall padding, and basketball nets. This new yearly cycle would allow capital improvements to be funded in a rolling cycle of annual aid provided by the state.

2022-23 will be dedicated to putting the "enjoy" back in learning. We continue with our mission to prepare our students to be successful, contributing members of their communities through excellence in education. Thank you for your continuing pride as Lions. We hope you will support us by voting on Tuesday, May 17th.

Boys State Delegate

Medal and Scholarship Program Winner



For many years, Rensselaer Polytechnic Institute, in conjunction with high schools around the country, has awarded the Rensselaer Medal to high school juniors who have distinguished themselves in mathematics and science. The RPI Medal in Science and Math has been awarded to Hua Qi Zhang, a member of the Class of 2023.

The Medal was first presented in 1916 with two purposes: to recognize the superlative academic achievement of young men and women, and to motivate students toward careers in science, engineering, and technology.

This \$30,000 per year merit scholarship is guaranteed for four years for each medalist who applies, is accepted, and chooses to enroll at Rensselaer. Rensselaer will be hosting an open house for all medalists in the fall.

Rochester Institute of Technology High School Awards Program

Wellsville Secondary School will again be participating in RIT's High School Junior Awards Program. The Computing Medal and Scholarship Program and the Award for Creativity and Innovation not only recognizes outstanding high school juniors, but also highlight RIT's leadership in computing education as well as its creative and innovative programs in many other disciplines ranging from engineering, sciences, and business to design, photography, film and crafts.

Nominees for the awards program must rank in the top 10% of the junior class, demonstrate leadership in school and community, and be pursuing a rigorous college-preparatory curriculum. Students selected to receive these awards are eligible for a \$32,000 scholarship (\$8,000 per year) if accepted and enroll at RIT. Students may use these scholarships to pursue any of the baccalaureate degree programs available at RIT.

We are proposing a reconstruction of the concession stand at our Elementary School turf field. The amount of the construction would not exceed \$2,100,000. In anticipation of this construction need, the District created a savings account for this project which the voters approved in May 2019. The amount in this reserve account is \$1,100,000. The remaining balance of construction would be from the existing fund balance. This allows funding of the proposed project without an impact on taxes.

The current concession stand was created in the 90's as a volunteer effort. The existing building has reached the end of its useful life.

The proposed athletic pavilion would have ADA-compliant restrooms at the turf level and the baseball level, locker facilities, athletic storage, a concession area, a public announcement space for Baseball, and bathrooms for officials.

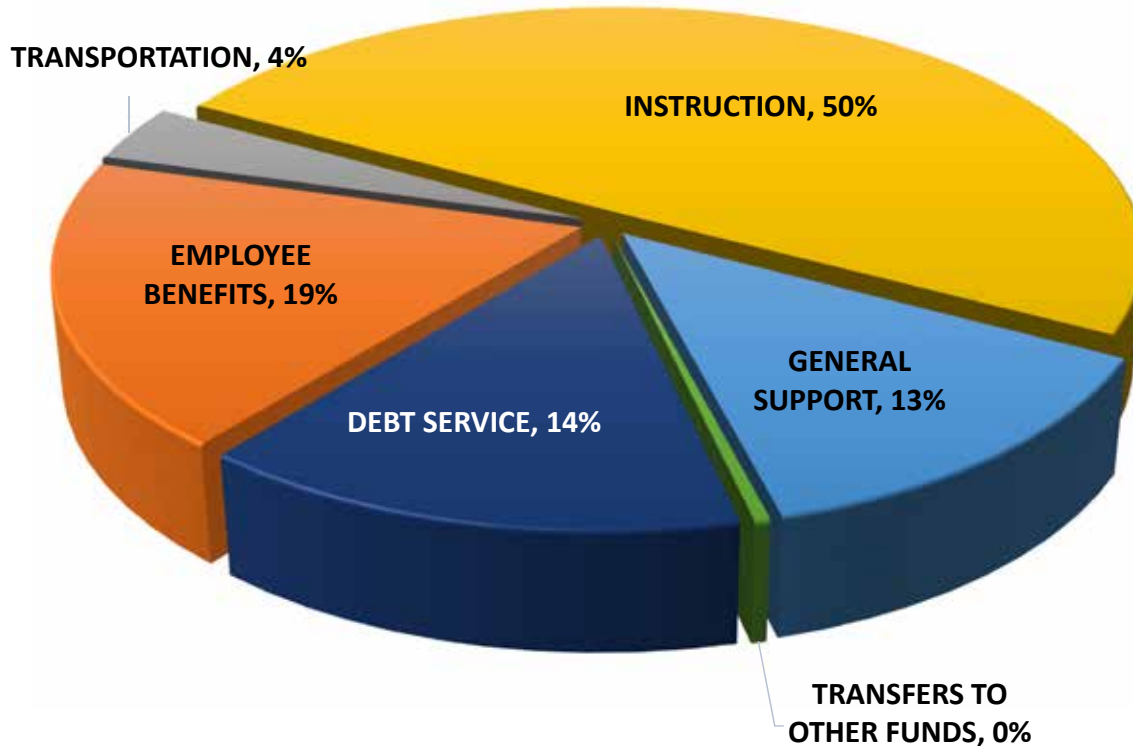
We propose a new facility in place of the current building to match the modern turf facilities constructed in 2003.

Two Candidates Running for Two Seats on School Board

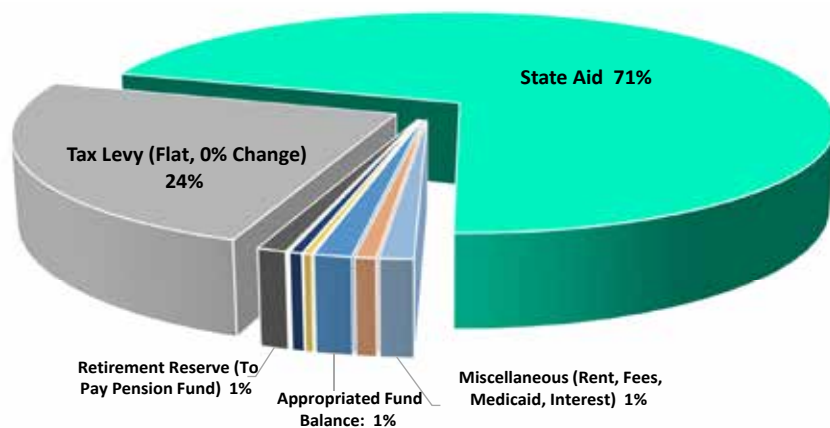

The Board of Education of the Wellsville Central School District, Wellsville, New York, hereby gives notice that an Annual District Meeting on the proposed 2022-23 budget (being Proposition No 1) and related propositions will be held at Wellsville Central School, Wellsville, New York, Elementary School Multi-Purpose Room, 50-98 School St., on the 3rd day of May, 2022, beginning at 6:00 p.m.

NOTICE IS ALSO GIVEN that a copy of the statement of the amount of money which will be required for the ensuing year for school purpose, exclusive of public moneys, may be obtained by any taxpayer in the District during the fourteen (14) days preceding May 17, 2022, except Saturday, Sunday, or a holiday, at the following school house in which school is maintained during the hours designated:

Wellsville Central School District Office, 126 West State Street, Wellsville, NY 14895 between the hours of 8:00 a.m. and 4:00 p.m.

NOTICE IS ALSO GIVEN that petitions nominating candidates for the office of member of the Board of Education must be filed with the Clerk of the District, 126 West State St., Wellsville, NY not later than 5:00 p.m. on April 18, 2022. The following vacancies are occurring:

1. Three (3) year term to expire June 30, 2025, current incumbent, Mr. Steven Pettenati;
2. Three (3) year term to expire June 30, 2025, current incumbent, Mr. Rex Olson

Each petition must be directed to the Clerk of the District, must be signed by at least twenty-five

(25) qualified voters of the District, must be filed with the district at least thirty (30) days prior to the budget vote on May 17, 2022, and must state the name and residence of the candidate.

NOTICE IS ALSO GIVEN that voting will be held on May 17, 2022, between the hours of 7:00 a.m. and 9:00 p.m. in the Secondary School Lobby (River Side Entrance) for the voting upon the election of two (2) board members of the Board of Education and to vote upon the acceptance of the proposed budget (being **PROPOSITION NO. 1**) for the school year 2022-23 and:

PROPOSITION NO. 2 RESOLVED that the Board of Education of the Wellsville Central School District No. 1 of the County of Allegany, is hereby authorized and directed to purchase two (2) 70 passenger conventional buses at a total maximum cost of \$300,000 or so much thereof as may be necessary to be raised by taxes on the taxable property of the said school district and to issue obligations of the school district, therefore, in accordance with the education law and local finance law:

PROPOSITION NO. 3 RESOLVED that the Board of Education of the Wellsville Central School District No. 1 of the County of Allegany, is hereby authorized and directed to increase the annual tax levy an additional \$16,595 and to pay over such funds to the trustees of the David A. Howe Public Library.

PROPOSITION NO. 4 BE IT RESOLVED, that the Board of Education of the Wellsville Central School District is authorized to construct an athletic pavilion, for use in student athletics, for an aggregate sum not to exceed two million one-hundred thousand dollars (\$2,100,000), with such sum or so much

thereof as may be necessary to be raised by (i) an expenditure not to exceed one million one-hundred thousand dollars (\$1,100,000) from the District's existing Capital Reserve Fund, established by the voters of the District on May 21, 2019, and (ii) monies derived from budgetary appropriations or other sources authorized by the voters, including unappropriated fund balance; and **BE IT FURTHER RESOLVED**, that the Board of Education shall be authorized to enter into one or more contracts on terms satisfactory to the Board of Education, with respect to material, services, equipment, and supplies hereby authorized to be acquired to complete the construction project.

AND NOTICE IS ALSO GIVEN that applications for absentee ballots to vote on these propositions may be applied for at the office of the School District Clerk, 126 West State St., Wellsville, NY at least seven days before the date of the aforesaid district meeting if the ballot is to be mailed to the voter, or the day before such district meeting if the ballot is to be delivered personally to the voter. A list of all persons to whom absentee ballots shall have been issued shall be available for public inspection in the office of the District Clerk during regular office hours on each of the five days prior to the day of the vote (excluding Saturday, Sunday, or a holiday) and such list shall also be posted conspicuously at the place of voting. An absentee ballot must reach the office of the District Clerk, 126 West State St., Wellsville, NY not later than 5:00 p.m. on the day of such district meeting.

AND FURTHER NOTICE IS HEREBY GIVEN that military voters who are not currently registered may apply to register as a qualified voter of the School District, if they meet the criteria for same. Military voters, as defined by Education Law 2018-d, may request an application to register as a qualified voter from the District Clerk. Military voter registration application forms must be received in the office of the District Clerk no later than 5:00 p.m. on the twenty-sixth (26th) day before the election. A military voter may designate a preference to receive a military voter registration, military ballot application or military ballot by mail, facsimile transmission or electronic mail in their request for such registration, ballot application, or ballot. Such designation shall remain in effect until revoked or changed by the military voter.

Notice is also given that there will be no separate registration required to vote in the election of School Board members or for the budget or separate propositions.

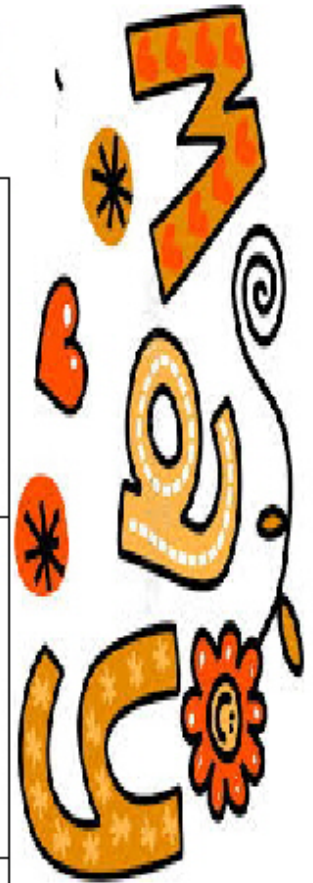
